

OFFICIAL RULES: PARTICIPATION AND REGISTRATION IN FUNDRAISING FOR HUMANKIND MINISTRIES'S SLEEP OUT ICT 2022 IS NECESSARY TO ENTER OR WIN. These Official Rules apply to all prizes and contests associated with HumanKind Ministries's Sleep Out ICT 2022. By participating in the contest, you are agreeing to the following rules, terms, and conditions, and you represent and warrant that you meet the eligibility requirements set forth herein. In addition, you agree to accept the decisions of HumanKind Ministries relating to this contest and prizes as final and binding. These contests and prizes are subject to all applicable federal, state, and local laws. The winner will be announced on Saturday, April 30th via social media and will be contacted directly via phone.. The winner will work directly with HumanKind's travel agent, Sunflower Travel Agency, to handle booking and travel arrangements. The prize includes the cost for up to 4 people, including flights, 2 days of Standard Theme Park Tickets* at *Walt Disney World*(R) Resort in Orlando, Florida, and a 3-night stay in one room at a *Walt Disney World*(R) Resort Hotel.
